- Responsible for business continuity management, including backup & recovery of data and other assets.
- Administer and operate all essential tools for deployment, testing, logging, monitoring, reporting, and alerting to maintain a stable and secure infrastructure.
- Implement and optimize security policies, encryption methods, key management, and access controls within our SaaS cloud environment.
- Automate and integrate security mechanisms into CI/CD pipelines to identify and resolve vulnerabilities early.
- Introduce and continuously improve security measures and incident management processes.
- Play a key role in the Information Security Management System (ISMS) aligned with ISO 27001, including execution of continuous improvement measures.
